



General Terms and Conditions – Addition “Dog SUP”

SUPSWISS is a trademark of KITESWISS GmbH. In the following Terms and Conditions, KITESWISS GmbH is named as the official contractual partner. These terms and conditions govern the relationship between you as a customer and KITESWISS GmbH as the course/tour organizer and contractual partner.

The German version of these General Terms and Conditions is the legal binding contract.

1. General rules

- § The dog owner makes sure to arrive in time for the course, in order to be able to start the course without stress for the dog.
- § The dog will have a chance to relieve him/herself before the course starts.
- § The dog owner is responsible to collect the dog excrement on the area around the SUP Center.
- § The dog owner is asked to try and control the dog's urge to mark around the SUP Center and especially the SUP material.
- § The course instructor will decide whether to keep the dogs on a chain or not. Golden rule: Either everybody is free or everybody is on a chain.
- § If the dogs are being held on a chain, the owners make sure to keep enough distance between the other participants.
- § Digging around the SUP Center is not allowed.
- § The dog owner informs the instructor about any unusual behaviors of his/her dog, especially fear or aggressions towards people or other dogs.
- § The dog owner informs the instructor about any restrictions given by the vet or other persons.
- § The instructor has the right to exclude participants if they are a disturbance to the course. Course cost will not be refunded.

2. Health

- § The dog owner confirms that his/her dog is healthy and does not carry any diseases. He/she also confirms that his/her dog has gotten the required vaccinations such as Staupe, Parvovirose and “Zwingerhusten”.
- § The vaccinations must be no older than one year.
- § Any type of disease has to be communicated to the instructor before the course starts. The instructor will then decide, if the dog can still participate in the course.
- § The dog owner needs to communicate at least 24 hours before the course start if his/her dog is in heat.

3. Liability

- § Participants must be covered for third party liability.
- § The dog owner takes responsibility for all damage done by course participants and the dog.
- § SUPSWISS is not taking any responsibility for damages on persons or material that occurred during the course.
- § SUPSWISS is being held responsible for damages that occurred intentionally by its instructors.



4. Contract

- § Participation in a course is only possible after booking the course through our website or via our staff.
- § Course costs need to be settled before the start of the course.
- § The participant agrees to the General Terms and Conditions when booking a course.
- § The dog owner is advised to read the T&C thoroughly.

5. Course

- § The final course schedule for courses over 90 minutes (between 9 and 12 pm) will be communicated via e-mail 72 hours prior to course start.

6. General

- § These Terms and Conditions are part of the General Terms and Conditions of KITESWISS GmbH.

7. Agreement

- § The participant accepts the T&C with the booking of a course.

8. Personal information

- § All participant's information is only used for course purposes and will be handled confidentially and not sold to third parties.

9. Place of jurisdiction

- § Place of jurisdiction is Zurich. The contract is binding to Swiss law.
